#### 1. Introduction

#### 1.1 External Advisory Boards

As per Consortium Agreement Art 6.8 (signed by all parties on 22 December 2022. TETTRIS will count on two advisory boards, external to the project consortium (the Consortium), that aim to provide advice and guidance on major issues related to 1) the strategic positioning of the project in the European landscape and identify strategic actions to be undertaken to consolidate and expand expected outcomes from the project (**Strategic Advisory Board-SAB**); and 2) the effective, smooth and successful implementation of the so called Third Parties Projects (3PPs) that will be instrumental to validate the products and results achieved throughout the lifetime of the project (**Community Implementation Board-CIB**).

Same article 6.8 indicates that the members of both external Advisory Boards shall be selected based on their recognized scientific or technical merit in relation to the content their advice is required for. The Technical Coordinator, with the support of the Project Management Team, in consultation with the project Coordinator and members of WP9 (Royal Belgian Institute of Natural Sciences-RBINS, Botanic Garden Botanic Museum, University of Berlin-FUB-BGBM, and Natural History Museum of Denmark-NHMD), has developed a process to compile a list of potential members among WP leaders and opened a period for nominations (here the <u>link</u> to the document in the CETAF shared Google drive)

The list is still not finalized and remains open as of 18.01.2023) since Consortium partners started to nominate candidates recently and consultation with potential members is still undergoing. The final list shall be put forward on a single slate produced by the Executive Board and submitted for voting by the General Assembly (GA) in an extraordinary meeting. To that end, the Executive Board will meet virtually on 30 January 2023 and decide on the proposed date to call for the extraordinary GA for approving the composition of the TETTRIS Advisory Bodies.

The Technical Coordinator and the Coordinator, supported by the Project Management Team (PMT), will run the organization and functioning of the following advisory bodies as specified in grant Agreement (art 6.8.1).

# 2. Rules of Procedures, roles, and responsibilities of the Advisory Boards (ABs)

The Advisory Bodies will individually have their own responsibilities and therefore, the profiles of their members should be adequate to the topics they will advise on. Moreover, basic principles shall be taken into consideration when approving final membership, including geographical spread, discipline coverage, gender and diversity balance.

#### 2.1. The Strategic Advisory Board (SAB)

The SAB will be formed as an external body of maximum 8 high-qualified experts to support the evaluation and strategic development of the project and the overall project

management specifically on those matters raised by the Coordinator and Technical Coordinator as well as the EB, and to provide recommendations for its improvement when necessary. Additional actions could arise from the GA, as the SAB will report directly to the governing body of the project.

The SAB will be instrumental to outreach outside the taxonomic community and open and consolidate strategic partnership with relevant stakeholders to the project. Equally, the SAB will facilitate understanding of the current and foreseen trends and challenges in the field of naturals sciences, taxonomy and biodiversity at large, and will meaningfully contribute to channel further efforts beyond the project lifetime. Its advice might be requested by the EB and/or the Technical Coordinator and the Coordinator on an ad-hoc basis.

#### 2.2. The Community Implementation Board (CIB)

The Community Implementation Board (CIB) will be formed by maximum 8 representatives of non-partners of the project to ensure wide coverage, uptake of the outcomes by the community and leverage on other complementary initiatives to TETTRIs.

The CIB is meant to be composed of individuals who represent key institutes and organizations throughout all societal sectors that are relevant to TETTRIs and its partnership. They will ensure a holistic understanding of taxonomy across the project and provide advice on how to connect with external stakeholders better and most efficiently during project implementation. Their contributions will also be relevant to perform qualitative analysis of the progress of pilots and projects that are to be funded under TETTRIs using the third-party funding programme.

The members of the CIB will have in-depth knowledge on the critical areas where support is needed on current initiatives related to broadly biodiversity-related challenges and be able to help prioritize the scientific and technical focus of the Consortium as to enable 1) inclusiveness and spread of activities across geographical areas, multidisciplinary of actions undertaken, and diversity of actors involved; and 2) smooth transfer of knowledge from the scientific community to societal actors. The Consortium members could eventually contact experts from: LERU (league of European Research Universities), CESAER (the Consortium of European universities of science and technology, EOSC (European Open Science Cloud), EEA (European Environmental Agency), Biodiversa+, ENVRI (Environmental Research Infrastructures), DiSSCo (Distributed System of Scientific Collections) and other Research Infrastructures (RIs), as well as other relevant initiatives to participate in the CIB.

#### 2.3. Preparation and organization of meetings of the Advisory Boards

#### 2.3.1. Convening meetings

The Technical Coordinator, with the support of the Project Manager, will invite the selected members of both, the SAB and the CIB, as proposed by the Executive Board and approved by the extraordinary meeting of the General Assembly, for a first meeting to be run virtually, separately whilst preferably close to each other in timing. In each of those meetings, the members of that Advisory Board will designate a chairperson for future meetings, mostly to be held virtually.

During those initial first meetings, the members of the corresponding Advisory Board will sign a "Mutual-nondisclosure agreement (NDA)" as per the Consortium Agreement (CA)

where the NDA template is enclosed in Attachment 5. The agenda of the meeting will be drafted by the Technical Coordinator and circulated on time to provide the members with content and supporting documentation to substantiate their envisaged work.

Additionally, during the first meeting the Technical Coordinator in agreement with the Coordinator and, with the support of the PMT will introduce the present Rules of Procedure and will open the discussion on possible complementary terms of reference for each of the Boards, should this be deemed necessary by the respective membership. In such a case, the Chair of the AB will lead the internal procedure and will inform both the EB and the GA by sharing the final document through the PMT. The final document will be uploaded in the Teamwork Platform

The chairperson of an Advisory Body will convene meetings of that Advisory Body, Those ordinary meetings shall take place as indicated in the CA at least once a year for the SAB and at least twice a year by the CIB. Other meetings may be convened as agreed by the corresponding membership. A Calendar of agreed meetings will be uploaded in the Teamwork Platform Calendar by the Project Manager.

To ensure correct alignment and through contributions to the development of the project, the Technical Coordinator (or anyone else in whom to delegate) will take part of the AB meetings.

#### 2.3.2. Notification of a meeting

The chairperson of an Advisory Body, via the Teamwork Platform or e-mailing, will give notice of a meeting to each Member of that Advisory Body and informed the Technical Coordinator and the PMT, no later than the minimum number of days preceding the meeting as indicated below:

Ordinary meeting

SAB 30 calendar days CIB 14 calendar days

#### 2.3.3. Agenda of the meeting

The chairperson of an Advisory Body will prepare and send each to each member of that Advisory Body a written (original) agenda no later than the minimum number of days preceding the meeting as indicated below:

SAB 14 calendar days
CIB 7 calendar days

Any Member of an Advisory Body may add an item to the original agenda by sending an email to all of the other Members of that Advisory Body up to the minimum number of days preceding the meeting as indicated below:

SAB 7 calendar days
CIB 2 calendar days

#### 2.3.4. Minutes of a meeting

The Technical Coordinator (or by delegation, the Technical Coordinator or a member of the Project Management Team) will write the minutes of the meetings and upload it in the Teamwork Platform to make them available to the GA and also to the EB that will channel the information to the project members, to its best consideration.

#### 2.4. Reporting of the Advisory Bodies

Both Advisory Bodies will report directly to the GA and on an *ad-hoc* basis to the EB and/or the Project Coordinator and the Technical Coordinator in case their advice is required to tackle specific topics.

They will participate in the GA (with voice but no voting rights). The communication between the Advisory Boards and the General Assembly is facilitated by the Technical Coordinator and the PMT, who acts as intermediate guaranteeing proper communication and reporting.
